

Greetings,

We left 2023 behind, the year when we celebrated the 100th anniversary of our Republic. Immediately following the pandemic period, economic difficulties, Russia-Ukraine crisis, Palestine problem, elections, February 6 major earthquake disaster, internal and external tensions, we demonstrated a good performance in our company in 2023, despite very difficult conditions.

We believe that in order for success to be sustainable, we must develop with ever-increasing effort. Since business life requires constant innovation, change and development. We work with great devotion with all our colleagues working in our company to carry İZAYDAŞ into the future in the best possible way.

Our turnover in 2023 exceeded the 400 Million TL cap. Approximately 4,500 analyzes were performed in our laboratory. 3,500 companies sent their waste, 370 of which were for the first time. We provided transportation services to 1,300 companies with 3,600 trips.

The amount of hazardous waste incoming for incineration was 42,000 tons, and the amount of hazardous waste incinerated was 39,000 tons. In response to these data, our energy production was 15 Million 300 Thousand kWh. 5 Million 150 Thousand kWh of this was sold to the national network.

The total of approximately 36 Million kWh of electrical energy was produced in the LFG facilities installed in our domestic waste landfills. With the production of 9 Million 800 Thousand kWh in our Hydroelectric Power Plant project and a total of 62 Million kWh of electrical energy this year with our Biogas facility, İZAYDAŞ has produced a production which covers the domestic electricity needs of a city with a population of 66 Thousand.

We swept 110 tons of waste from the sea surface. The number of our visitors in 2023 was 2,100 people. Our R&D studies continued and we successfully completed major maintenance in our facilities. We invested around 100 Million TL in fixed assets with the support of our metropolitan municipality for all these.

I would like to thank my colleagues who contributed to these studies and contributed to reaching these figures with great devotion.



INTEGRATED MANAGEMENT SYSTEM Certification Body Audits (Third Party Audits)

The integrated management system surveillance audit was conducted by the certification body Qualityst on 11-12.09.2023. 



Customer Satisfaction Research

The customer satisfaction research was conducted by a survey method by an outsourcing research company. The research; was applied to four customer groups: loyal-irregular customers, potential customers, customers receiving laboratory services and customers receiving proficiency testing services. The research results were reported by the research company from which the service was received and an information presentation was made on 23.02.2023. Based on the results, the rate of customers finding İZAYDAŞ successful is 94.7% and customer satisfaction is 82.7 points. According to the research results, issues in need of improvement were followed by action planning.

ENVIRONMENTAL MANAGEMENT SYSTEM

Temporary Activity Certificate / Environmental Permit and License Certificate

Since the current Environmental Permit and License Certificate will expire on 24.08.2022, renewal works have been commenced. Due to the amendment made in the Environmental Permit and License Regulation on 16.10.2021 and the Regulation on the General Principles of Waste Pretreatment and Recovery Facilities published on 09.10.2021; Since the following obligations have been imposed;

- ✓ Obtaining a Pre-Process license for Collection-Separation Facilities (TAT),
- ✓ Licensing the hazardous waste recovery license as a hazardous waste pre-treatment license.

the new Environmental Permit and License Certificate, effective/valid until 18.08.2028, which includes all activities, was received on 18.08.2023.



Studies within the Scope of Zero Waste Certificate

With the aim of preventing waste, using resources more efficiently, reducing the amount of waste, and leaving a clean world for the future by recycling waste, we have been conducting the separate collection of packaging waste activities within the Company since 2011. With the entry into force of the Zero Waste Regulation, we became the first business in Kocaeli to receive a Zero Waste Certificate. With the success of becoming a facility, the work continued in 2023.

Kocaeli Chamber of Industry – Şahabettin Bilgisu Environment Awards

"Kocaeli Chamber of Industry Şahabettin Bilgisu Environmental Awards" award program has been organized by Kocaeli Chamber of Industry since 1995 in order to reward industrial organizations that contribute to the development of environmental awareness, protection and improvement of the environment. In the award organization held for the 29th time in 2023, the companies that applied were assessed by being part of the Field Audit Team in order to find the winners of the environmental awards in the Large-Scale Company and SME categories. An Award Ceremony was organized and presented by Kocaeli Chamber of Industry on 15.06.2023 for the businesses that were rewarded as a result of the evaluations.

Environment Inspections

An inspection was conducted by the Ministry of Environment, Urbanization and Climate Change within the scope of Environmental Permit and License Application on 24.03.2023. On 04.08.2023, a sudden inspection was conducted by the Provincial Directorate of Environment, Urbanization and Climate Change within the scope of Waste Interim Storage - Non-Conformity Letter Physical Conditions Control. No nonconformities were ascertained during the inspections.

ISO 14064 Corporate Carbon Footprint Calculation Study

A contract was signed with Şti. 2021 was taken as the base year and meetings and studies relating to reporting were held during the year. Energy Management System Certificate

ISO 50001:2018 standard certification audit of the Energy Management System for 2023 was conducted by the certification body KALİTEST on 07-08.12.2023. As a result of the audit, the documents showing the compliance of the Energy Management System being implemented with the relevant standard were renewed and our certificate was renewed until 10.12.2026.

LABORATORY

IZAYDAŞ Laboratory has managed to increase its paid analysis revenues compared to the previous year by closely following the legal and commercial developments in the sector.

- In the Sampling Area; Rivers and Streams, Groundwater, Lakes and Ponds, Sea Water, Solid Wastes, Sludge Samples from Sewage Water and Treatment Facilities, Sampling from Surface Soil, Manual Sampling from Petroleum Liquids, Sampling from Insulating Fluids, Emission and Immission Measurement and Sampling;
- In the Field of Proficiency Testing with ISO 17043 Accreditation Certificate; it provides services within the scope of Waste, Waste Water, Waste Oil, Sea Water and Soil.

Independent Audit

In line/accordance with the Turkish Commercial Code (TCC) No. 6102, our company has been included in the scope of compulsory independent audit and has been certified by Independent Auditor Etken Independent Auditing and YMM A.Ş. A contract was made with. The opinion given in the Independent Audit Report; The financial information included in the annual activity report of the board of directors is consistent with the audited consolidated financial statements in all material respects and reflects the truth.

In the section of other liabilities arising from the legislation, it has been indicated that in line/accordance with the third paragraph of Article 402 of the Turkish Commercial Code (TCC) No. 6102, there is no significant uncertainty relating to whether the business will be able to continue its activities in the foreseeable future within the framework of continuity, according to BDS 570.

ADMINISTRATIVE AFFAIRS

An inspection was conducted within the scope of the Nutrition-Friendly and Physical Activity-Supporting Workplace Application we filed to the Provincial Health Directorate, and as a result of the inspection, it was considered appropriate to issue a certificate to our workplace.





The parking lot was completed by the KBB Department of Technical Affairs by way of laying 8,400 m³ of excavation, 6,400 m³ of filling material, 3,350 tons of plantmix base material, 2,410 tons of bituminous asphalt and 1,550 tons of binder asphalt in the guest, personnel and waste vehicle parking lot.





SUPPORT SERVICES

Hazardous Waste Transportation

In line/accordance with the Environmental Law and the Communiqué on the Transport of Waste on Highways; Hazardous waste shall be transported by persons, institutions or organizations that have a transportation license from the relevant governorship.

IZAYDAŞ provides hazardous waste transportation services with its 11 licensed vehicles and 13 certified drivers. As of 2023, it has provided 16,580.53 tons of hazardous waste transportation services. In addition, 1,013.13 tons of sludge, hazardous waste and domestic garbage were transported from Derince Waste Reception Facility to Izmit Facility in a total of 256 trips.

Clinical and Hazardous Waste Incineration and Energy Production Facility

The operating principle of the facility, which has a burning capacity of 5,400 kg/hour, is to burn flammable plastic wastes from industry, used oils, pharmaceutical and cosmetic wastes, petrochemical wastes, PVC, solvents, paint wastes, adhesives and adhesives, treatment sludges, etc. which is based on the disposal of hazardous waste and clinical waste by burning.





Wastes Disposed of by Incineration

Data relating to the wastes disposed of by incineration in the incineration facility in line with the waste acceptance criteria are given in the table below. 144,474 Sm3 of natural gas was consumed as additional fuel in the combustion facility in 2023.

Incineration Plant Performance

As of the end of 2023, the facility's total operating hours were 7,549 hours, incidental downtime hours were 539 hours, and planned maintenance downtime hours were 672 hours.

Incineration Plant Energy Production

39,065 tons of these wastes were burned, and 15,294,910 kWh of electrical energy was produced within the framework of the 49-year electricity production license in 2023. 11,070,240 kWh of this was consumed at the facility, 5,101,970 kWh was sold to TEİAŞ and 903,500 kWh of electricity was purchased.

RECYCLING

Medical Waste Collection, Transport and Disposal Work

Medical waste generated in all health institutions within the borders of Kocaeli province is collected by licensed medical waste transportation vehicles and transported to the İZAYDAŞ site. After the infected medical wastes are sterilized and shredded in the Medical Waste Sterilization Facility, they are ultimately disposed of in the Class 2 Regular Landfill. Pathological wastes are burned in the Hazardous Waste Incineration and Energy Production Facility.

Bio-gas Plant

The biogas is obtained as a result of anaerobic digestion by using cattle manure, fruit and vegetable waste, rumen waste, grass and process-compatible food industry waste in the Biogas Facility. The produced gas is converted into electrical energy with the help of a gas engine. The heat energy generated by cooling the gas engine is used to heat reactors operating under mesophilic conditions.

ATY Plant

With the idea of converting industrial hazardous wastes, including bulky wastes, into fuel, work has been initiated to establish a Refuse-Derived Fuel (RDF) Facility within İZAYDAŞ. The facility construction has been completed and the RDF facility process main equipment orders have been installed.

The basic components of the RDF facility are crushers, conveyors, equipment to separate materials according to weight and size, fire and ventilation equipment and work machines.

A tender was held on 23.06.2010 for the Construction and Operation of İZAYDAŞ İzmit and Dilovası Domestic Solid Waste Sanitary Landfill Landfill Gas (LFG) Electricity Production Plant. As the result of the tender, Izmit Storage Facility started electricity production on 02.03.2012, as a result of the electrical connections and the completion of electricity production. The total gross amount of energy produced in 2023 was 33,896,160 kWh/year.

There are two gas engines in the Dilovası Sanitary Landfill. The engines have an installed capacity of 1,063 MW and the facility operates at full capacity for more than 8,000 hours per year. energy produced in 2023 was 1,943,350 kWh/year. Since waste is not removed, energy production has decreased.

Groundwater / Leachate Analysis

In line/accordance with the "Regulation on the Regular Storage of Waste", samples were taken from the Groundwater Wells and Leachate Collection Manholes located in Izmit and Dilovası Landfills and analyzed in 2023.

Significant Projects Commissioned in 2023

On 05.06.2023, concrete road construction work was completed on the roundtrip and waste dump route of Lot 7 A area. It was opened for use on 30.06.2023.





The 2,580-meter collector line was cleaned regularly in 2023 by taking camera images up to the İSU main connection point by means of outsourcing.





LABOR HEALTH AND SAFETY

Work Accidents

The number of minor and major work accidents has been recorded as 33 as of the end of December 2023. First aid, medical intervention and hospital transfer were provided to 33 victims of 33 work accidents. 26 working days were lost due to 33 work accidents in 2023.

We keep the track of number of accident-free working days in our facility on our board located above the shift supervisor. If there are two or more lost working days in our dashboard as a result of accidents experienced by İZAYDAŞ employees, we reset our dashboard. 45 accident-free working days have been recorded as of 31.12.2023. Our record for accident-free working days is 568.

With the objective to test the TAMP-Kocaeli Disaster Response Plan and its annexed disaster group plans within the disaster response system and to improve inter-institutional cooperation and coordination, a table-top-field exercise was held simultaneously at 14.00 on Wednesday, November 15, 2023, in different locations. The intervention, ensuring area safety and intervention processes were observed in the announced drills held in the İZADAŞ Hazardous waste R&D Area (Old Truck Parking Area), in which KBB, its subsidiaries and our institution were involved.
